ccording to North-Aampton County's independent auditor, the county is in desperate financial straits. That's what Nancy Gunza, a CPA with CliftonLarsonAllen, told council's Finance Committee June 18. She explained that the unrestricted reserve fund at the end of last year was just \$11.1 million. The county spends about \$9-10 million per month.

"That's a pretty low amount," said Gunza, who added that the Government Finance Officers Association recommends six months of expenses in reserve as a best practice, with a three-month

What happened to \$25 million stabilization fund?

Council member Ken Kraft challenged Gunza's statement, insisting that the \$11.1 million figure she quoted is in addition to the county's \$25 million stabilization, or rainy day fund. In fact, he insisted that \$25 million is there "to keep this ship going" in the event of a catas-

trophe. It's not.

"We have a \$25 million stabilization fund that we're not allowed to touch," he insisted.

"You had \$25 million," said county Fiscal Director Doran Hamann. "I think the word is you 'had' 25." The fiscal director added that last year, "We spent \$14 million in excess of our revenues," which brought the stabilization fund down from a healthy \$25 million to an unhealthy \$11.1 million. Hamann also warned council last year, during budget hearings, that the county would need to dip heavily into reserves because it was spending more than it was taking

Gunza added that the total fund balance at the end of last year was just

\$28 million. Still perplexed, Kraft asked Controller Steve Barron to name the \$25 million rainy day fund. Barron was unable to do Hamann explained a sec-

New pastor; new commitment

St. Peter's Evangelical utheran Church

or the first time since 1992, St. Peter's Evangelical Lutheran Church in South Bethlehem installed a new senior pastor June 8. He is The Rev. Gerald S. Kulp, a cleric strongly committed to keeping his church in the city at a time when other congregations are moving to the sub-urbs. He expressed his commitment as keeping St. Peter's "in the city for good; in the city for

In recognition of this commitment, and the contributions

made by St. Peter's to the community, Bethlehem Mayor Robert Doncez proclaimed June 8 as The Rev. Gerald S. Kulp Day. The proclamation noted that St. Peter's church has stood in South Bethlehem since 1863, and during those years it has served a multitude of charities, including the Bethlehem Sheltering Ministry, the Meal Center and the Food Bank.

The proclamation also cited Rev. Kulp's efforts to help open the church's doors to Head Start, Special Olympics and numerous other programs.

"Pastor Jerry has walked the neighborhood regularly, interact-

ing with the people and places in this part of the city, so that he knows them, and they know

him," the proclamation read. Bishop Samuel Zeiser of the Northeastern Pa. Synod of the Evangelical Lutheran Church of America officiated at the installation, attended by several hundred members from various congregations throughout the area. During his sermon, the bishop talked about the gifts individuals possess, and noted "every member of every congregation has something to give." He chal-lenged the St. Peter's worshipers to recognize how their gifts were



Walk repairs set for

In contrast to the ran-Lcor at some recent meetings of Bethlehem City Council, Council President J. Willie Reynolds was able to breeze through the agenda at the June 17 meeting. Nine appointments to the Historic Conservation Commission were approved unanimously. So were several requests to authorize grant applications for sidewalk repairs on Main Street and on the city's Southside.

As explained by Public Works Director Michael Alkhal, the city is seeking a \$250,000 grant for a \$500,000 sidewalk repair and streetscaping project along Main Street, between Market and Walnut streets.

Council member Michael Recchiuti was concerned about the merchants along Main Street who will contribute \$125,000 for these repairs. He asked, "Are they on board with this?" Alkhal answered that he will meet with them, but said the cost to them is now

'In the city for good; in the city for God'


The newly installed senior pastor of St. Peter's Evangelical Lutheran Church faces a number of serious challenges to his commitment to keep the 151-year-old church in South Bethlehem – challenges the Rev. Gerald Kulp says are not unlike those faced by mainstream and nondenominational churches

throughout the country.
'In the decades of the 1940s, 50s and 60s, churches were the center of social life for city dwellers. The expectation then was that the children and grandchildren of families would keep going to same church for generations. Most did not foresee the move of congregations into the suburbs, the decline in overall attendance and, worse, rejection of God and organized reli-

Currently, 73 percent of Americans identify themselves as Christians, down from 86 percent in 1990, and 76 percent in 2008. A 2013 survey conducted by the Public Religious Research Institute reported that 31 percent of Americans attend religious services at least once a week, and a Gallup poll has set the number at 40 percent. Even these low figures have been refuted by several researchers who say that even taking a broad definition of attendance as three out of every eight Sundays, the real percentage is closer to 23 to 25 percent.

Most disturbing to clergy however, are the 2012 Pew Research Center findings that doubts about the existence of God have increased rapidly among younger respondents. In that study, 68 percent said they "never doubt God's existence," down 15 points from the 83 percent just five years

From a peak of 200 worshipers a week in 2008-2009, today there are 130-140 attending the three services out of a total membership of 615. That represents only 27 percent in attendance, according to Kulp. He said he wants to increase attendance by 35-40 percent, but he also needs to raise the membership number.

"The numbers tell a story," Rev. Kulp said, "but the real issue is to get people passionate about being followers of Jesus Christ. The challenge is how we share the gospel to people and make it relevant to the 360 hours in their week." country ministry. A captain in the U.S. Army from 1985-91, Rev. Kulp served as an infantry company commander.



Soccer fans return to SteelStacks

Although the United States team lost its match against Germany, it has advanced to the next round of the World Cup.

The 2014 FIFA World Cup SoccerFest and Viewing Party at SteelStacks June 26 was attended by many, though the numbers were fewer than the estimated 10,000 fans that came out for the June 22 game against Portugal.

Unlike the game against Portugal, the match against Germany was scheduled for noon, when most adults were at work.

On Wednesday night, U.S. Soccer tweeted a picture of a letter written by U.S. Men's National Team head coach Jurgen Klinsmann attempting to excuse soccer fans from work to

from work on Thursday, June 26th," explaining, "The #USMNT has a critical World Cup game vs. Germany and we will need the full support of the nation if we are to advance to the next round."

Although some fans may have attempted to print and use this letter, a smaller number of adults attended this game, bringing with them a greater number of children than at the June 22 game. The children enjoyed the free sticker books that were being handed out near the entrance.

The number of U.S. supporters outnumbered those of Germany by a greater ratio than seen at the match against Portugal.

Fans' responses to the outcome of the game varied from disappointed to hopeful. Even without scoring any goals against Germany, the U.S. team has secured its spot in the 2014 World Cup.

"Yes and yes," Kevin Morrissey of Bethlehem answered when asked if the results were expected. "I was hopeful we'd get through the group but obvi-



Team out to pROVe their skills

A team of homeschoolers from the Lehigh Valley traveled to Alpena, Mich., in late June to compete against top teams from around the world in the Marine Advanced Technology Education (MATE) Center's 13th annual International Student ROV Competition. The local team placed first at a regional competition, the MATE Pennsylvania ROV Challenge at Rowan University May 10.

ROVs, or remotely operated vehicles, are underwater vessels that can be used for a variety of tasks. This year's competition theme was "Exploring the Great Lakes: Shipwrecks, Sinkholes, and Conservation.'

The team, known as pROVe (Pennsylvania ROV Engineers), designed and built an ROV capable of exploring and documenting shipwrecks, studying sinkholes and preserving national maritime heritage sites.

In addition to using their ROV to complete a series of missions involving a simulated shipwreck site, the team was required to compile a 20-page technical report, create a poster display, make a presentation to a panel of judges and design a team T-shirt.

At the competition, the team took first place in mission scores, third place in the tech report, third place in the poster display, and the special SME Design Elegance Award for design aesthetics, simplicity and functionality.

This is the third year the pROVe team has competed in the event, and this will be their third time traveling to internationals. Team members include David Sampsell, Natalie Sampsell, Hannah Smith, Stephen Gahman, Timothy Gahman and Ben Green.

'Jersey Boys' sings it like it was

After Frank Sinatra and before Bruce Springsteen those other Jersey Boys), MOVIE there was The Four Seasons, one of the top pop REVIEW groups of all time, having By Paul Willistein sold 100 million records.

The Four Seasons were rivaled The Beatles on the record charts, resulting in the 1964 Vee-Jay promotional album, "The Beatles vs. The Four Seasons: The International Battle

Of The Century."

The Four Seasons' recordings influenced not only Springsteen, but Brian Wilson of The Beach Boys and a generation of songwriters and hit-makers.

The Four Seasons' sound combined Frankie Valli's amazing falsetto and expressive lead vocals, augmented with echo chamber and vocal overdubbing, with the bass vocal of doowop groups and the bigdrum and bass production sound of Bob Crewe and catchy music and lyrics of Bob Gaudio (some co-written with Crewe).

Behind every great poprock band is a story. These stories have been fodder for MTV rockumentaries and VH1 rock docs. The rock 'n' roll and pop star biopic has been a staple of Hollywood movies for decades. "Jersey Boys" is in the tradition of the great rock 'n' roll movie biopics.

"Jersey Boys" gives the story behind all those Baby Boomer era hits by The Four Seasons sung along to and enjoyed by the dash-

board lights. The movie, and the musical stage show it's based on, enshrines Frankie Valli and the Four Seasons, inducted in 1990 into The Rock And Roll Hall Of Fame, for a string of early- to mid-1960's hit pop songs, including "Sherry," "Big Girls Don't Cry," "Walk Like A Man," "Candy Girl," "Dawn," "Rag Doll," "Bye Bye Baby (Baby Goodbye)," 'Working My Way Back To You," "Let's Hang On" and "Can't Take My Eyes Off Of You" (released as a solo

by Valli). Valli (born Francesco Stephen Castelluccio) had the title song from the movie, "Grease" (1978) and the hit songs "My Eyes Mike Doyle a Adored You," "Swearin' To God," "Who Loves You" and "December, 1963 (Oh, What A Night).'

Valli continues to tour and present concerts.

'Jersey Boys," directed with consummate and understated skill by Clint Eastwood, is based on the hit Broadway play, "Jersey 2005 and received six Tony Awards.

While the founding of the Four Seasons group and the shaping of the hits is fascinating, the story behind the group is astounding, jaw-dropping and, at times, hilarious. Yes, the group was named Union Township, N.J., min.; Distributed by Warnwhere it performed.

It seems that for success so popular, the group in the music business, sheer vocal talent, musicianship and great-sounding records aren't enough. Success takes muscle. And, if the storyline in "Jersey Boys"

There's also a seeming-ly rival "wise guy," who latched onto the Four Seasons tuxedo coattails early: Norm Waxman (Donnie Kehr), who, the movie tells us, the band ended up in hock to, to the tune of something like \$162,000.

That, combined with some \$600,000 in other debt that one of the Four Seasons' band members allegedly racked up, led Frankie Valli to go back on the road for many years to pay down what we're told was \$1 million the band was indebted for.

In the screenplay by Marshall Brickman ("Annie Hall," 1977; "Manhattan," 1979), who co-wrote the book for the musical with Rick Elise, "Jersey Boys" weaves in Valli's marital problems, as well as the individual problems of the group's members.

Eastwood makes a bold choice in having each of the Four Seasons talk directly to camera, in keeping with the concept of the stage play, "Jersey Boys." This gives the story the sense of "Rashomon" (1950) and a Shakespeare play.

John Lloyd Young, who played Frankie Valli in the Broadway show, is terrific in voice and attitude.

Vincent Piazza as Tommy DeVito, the group's guitarist, explodes off the screen as someone "not properly socialized.'






